Report of the Interim Executive Director

Pension Consulting Services – Mr. Butcher advised that Altigro Pension Services, Inc. ("Altigro") is preparing to take the next step in the distribution of funds from the 403(b) pension plan (the "403(b) Plan"), and that he has had substantial discussions with Altigro regarding the Defined Benefit pension plan (the "DB Plan") as well, including the discovery of information about the DB Plan previously. Mr. Cornish noted that Genova Burns Giantomasi Webster LLC ("GBGW") will advise the Board in its determination of whether to submit plans to terminate both the 403(b) Plan and the DB Plan to the IRS, and other issues related to the investment of funds in the DB Plan.

Vehicles – Mr. Butcher noted that the NWCDC is now prepared to obtain title to the vehicles it had previously financed, and to then transfer title to those vehicles to the City of Newark (the "City").

Website – Mr. Butcher also advised that the NWCDC is working to update its website and to merge its website into the City's webspace to ensure that there is no disruption in service to the public.

RFQ for Legal Services – Mr. Butcher noted that the NWCDC received proposal qualifications in response to its RFQ for general legal services.

Insurance Matters

Directors and Officers Insurance – Mr. Cornish advised that GBGW has been working with Conner, Strong & Buckelew, Inc. ("Conner Strong") to assemble and submit the NWCDC's application for increased Directors and Officers ("D&O") liability coverage from RSUI, Inc. ("RSUI"), but that the NWCDC's application has not yet been submitted. The Board discussed its desire to submit the application in the near future.
