General Update

Accounting Services – Mr. Cornish advised that Donohue Gironda & Doria ("Donohue") expects to have the NWCDC's 2012 trial balance finished by next week, and that this trial balance is what the NWCDC's auditing consultant, Wiss & Co. ("Wiss"), will use to complete its 2012 annual audit.

Auditing Services – Mr. Cornish advised that both Wiss and Donahue will work in tandem to complete the 2012 audit, and that both believe that the 2013 audit will be simpler than the 2012 audit. Mr. Cornish also advised that Wiss has broadened its standard for material transactions for the 2012 audit.

Investment Advising Services – Mr. Cornish advised that Meketa Investment Group, the NWCDC's investment advisor regarding its Defined-Benefit pension plan ("DB Plan"), is nearly ready to implement its recommendation regarding the allocation of the DB Plan assets, and is waiting on a signature from Trustee Merritt to proceed.

Insurance Procurement – Mr. Cornish advised that the NWCDC is no longer working with Conner Strong & Buckelew as an insurance broker, but that Mr. Butcher may have been working with someone to procure renewals of certain insurance policies that expire on June 1, 2014, and that Genova Burns Giantomasi Webster LLC ("GBGW") would inform the Board regarding any signatures and authorizations that may be necessary.

Banking Issues – Mr. Cornish advised that a resolution has been prepared regarding removal of Mr. Butcher from the NWCDC's bank accounts.
